TO: FORMER STATEWIDE INSUREDS, PERSONS HAVING CLAIMS AGAINST FORMER STATEWIDE INSUREDS, INSURERS POSSESSING CLAIMS FOR CONTRIBUTION OR RIGHTS OF SUBROGATION AGAINST STATEWIDE, AND OTHER GENERAL CREDITORS OF STATEWIDE

**RE: STATEWIDE INSURANCE COMPANY, IN LIQUIDATION (“STATEWIDE”)
NOTICE OF SECOND CLAIM FILING DEADLINE OF MARCH 31, 2014**

Pursuant to an Order entered by the Circuit Court of Cook County, Illinois (the “Supervisory Court”), the Liquidator of Statewide Insurance Company (“Statewide”) recently distributed a 100% dividend on all claims that were timely-filed on or before the first (original) claim filing deadline of January 6, 2005 and allowed at priority levels (a) through (g) of the Illinois statutory distribution schedule, 215 ILCS 5/205(1)(a)-(g).

Subsequent to paying the foregoing claims in full, and establishing a reserve to provide for the payment of any remaining claims by state insurance guaranty funds/associations and future costs of administration, the Liquidator has determined that a surplus (“Surplus”) of estate assets will remain. The Liquidator accordingly petitioned and obtained an order from the Supervising Court establishing a **second claim filing deadline of March 31, 2014** for purposes of affording claimants that may have new claims to report, long-tail claims to report in the future, and claimants that previously presented late-filed proofs of claim to the Liquidator, an opportunity to share in any distribution of Statewide’s Surplus that may be made by the Liquidator. Potential claimants may include former Statewide insureds, persons having claims against former Statewide insureds, insurance companies possessing claims for contribution or rights of subrogation against Statewide, and other general creditors that provided goods or services to Statewide.

Claimants that previously presented timely-filed claims to the Liquidator, which were either allowed or disallowed by Order of the Supervising Court, are prohibited by the Supervising Court’s order from presenting the same claim to the Liquidator again, unless they have evidence of additional losses to report that were not previously presented to the Liquidator for consideration.

Claimants that previously presented late-filed proofs of claim, after the expiration of the first claim filing deadline, do not need to present their claim to the Liquidator again, unless they have evidence of additional losses that were not previously reported.
