ORDER

THIS CAUSE COMING TO BE HEARD upon the Application of Michael T. McRaith, Director of Insurance of the State of Illinois, in his capacity as Liquidator (the "Liquidator") of Alliance General Insurance Company ("AGIC"), pursuant to Section 210(1) of the Illinois Insurance Code (the "Code"), 215 ILCS 5/210(1), for the entry of an order authorizing him to declare a one hundred percent (100%) dividend on all claims allowed, or to be allowed, for distribution at priority level (d) of the Code, 215 ILCS 5/205(1)(d); the Court having jurisdiction of the parties and the subject matter; the Court having reviewed the Application and having heard counsel for the Liquidator, and being fully advised in the premises;

IT IS HEREBY ORDERED THAT:

A. The Liquidator is authorized to pay a one hundred percent (100%) dividend on the 284 claims previously allowed by this Court:

B. The Liquidator is hereby authorized to pay a one hundred percent (100%) dividend on each claim allowed in the future by this court at level (d) of the priority schedule,

215 ILCS 5/205(1)(d), after the court's order approving the allowance of such a claim becomes final and non-appealable; and

C. Payment of the one hundred percent (100%) dividend on an allowed level (d) claim, 215 ILCS 5/205(1)(d), will constitute a full and final settlement of AGIC's obligations on the underlying claim.
