ILLINOIS RESTAURANT RISK MANAGEMENT ASSOCIATION INC., IN LIQUIDATION

On November 30, 2011, an Agreed Order of Liquidation with a Finding of Insolvency was entered against Illinois Restaurant Risk Management Association Inc., ("IRRMA") by the Circuit Court of Cook County, Illinois. In connection therewith, the Court has ordered that IRRMA be liquidated pursuant to the provisions of the Illinois Insurance Code, 215 ILCS 5/187, *et seq.* Andrew R. Stolfi, Acting Director of Insurance of the State of Illinois, was affirmed the statutory Liquidator of IRRMA (the "Liquidator") and is authorized to take such actions as the nature of the cause and the interests of IRRMA, its policyholders, members, creditors or the public may require.

The records of IRRMA indicate that you are the attorney of record for the above captioned claimant who has a pending workers' compensation claim for which he/she has been receiving medical and/or disability payments. Please be advised that under the terms of the Insurance Code and the Order of Liquidation, IRRMA will no longer be permitted to make regular medical or disability payments. Instead, a claim filing deadline will be established by the Supervising Court, in order for all potential claims against IRRMA to be presented, valued, and paid on a pro rata basis from the assets of the IRRMA's estate. The claimant may also be entitled to receive additional compensation toward satisfaction of his/her claim from the Group Workers' Compensation Pool Insolvency Fund pursuant to 215 ILCS 5/107a.13.

Claimants who may have a claim that was previously asserted against IRRMA, and which remains open and pending on the books and records of IRRMA, need not file a proof of claim form. Their claim will be deemed timely-filed by the Liquidator.

Claimants who may have a claim that has not previously been reported to IRRMA or which is no longer pending as an open claim on IRRMA's books and records must file a proof of claim form on or before the claim filing deadline that is established by the Supervising Court. Inquiries to determine whether a claim is currently pending and requests for proof of claim forms may be presented to the Liquidator through our website at www.osdchi.com, by mail, IRRMA c/o The Office of the Special Deputy Receiver, 222 Merchandise Mart Plaza, Suite 1450, Chicago, Illinois 60654, or by calling OSD at (312) 836-9500.

I ask for your patience in this matter and regret any inconvenience or hardship the insolvency and liquidation of IRRMA will cause you.
