**ORDER APPROVING THE LIQUIDATOR'S UNCONTESTED
RECOMMENDATIONS FOR THE DISALLOWANCE OF 945
CLAIMS AT LEVEL D OF THE SCHEDULE OF PRIORITIES**

THIS CAUSE HAVING COME TO BE HEARD on the petition (the "Petition") of Dana Popish Severinghaus, Director of the Illinois Department of Insurance, in her capacity as the statutory and court appointed Liquidator (the "Liquidator") of Lumbermens Mutual Casualty Company (the "Estate"), for the entry of an order approving her uncontested recommendations for the disallowance of the 945 claims set forth in Paragraph 2 of this Order, for purposes of barring each such claim from participating in any distributions of Estate assets that may be made at priority level (d) of the statutory schedule of distribution, 215 ILCS 5/205(1)(d), ("Level D"); due notice having been given; the Court having jurisdiction over the parties hereto and the subject matter hereof; the Court having heard from counsel for the Liquidator thereon; and the Court having been otherwise fully advised in the premises;

THE COURT FINDS:

The Liquidator has represented in her Petition that:

- A. Written notices of determination ("NOD") setting forth the Liquidator's recommendation for disallowance of their claim and of the timelines and procedures for the submission of objections to the NOD were mailed to each the 945 claimants identified in both Paragraph 3 of the Petition (the "Claim Recommendations") and Paragraph 2 of this Order; and,

- B. The statutory sixty-day period for submitting written objections to the NODs has passed and that there are no objections pending with respect to these 945 claims; and,
- C. The Claim Recommendations are, therefore, uncontested.

IT IS HEREBY ORDERED THAT:

1. The Liquidator's Petition is granted; and
2. The 945 claims identified in pages 3-25, below, are disallowed and barred from participating in any distributions of Estate assets that may be made on timely filed claims allowed at Level D:
