**PETITION FOR APPROVAL OF THE LIQUIDATOR'S  
UNCONTESTED RECOMMENDATIONS FOR THE DISALLOWANCE  
OF 1,000 CLAIMS AT LEVEL D OF THE SCHEDULE OF PRIORITIES**

NOW COMES DANA POPISH SEVERINGHAUS, Director of the Illinois Department of Insurance, acting solely in her capacity as statutory and court-affirmed liquidator (the “Liquidator”) of Lumbermens Mutual Casualty Company (“Lumbermens” or the “Estate”) by and through her attorneys, and petitions this Court (the “Petition”) for the entry of an Order approving her uncontested recommendations for disallowance of the 1,000 claims identified in Exhibit 1 to this Petition and barring each such claim from participating in any distributions of Estate assets that may be made on claims allowed at level (d), 215 ILCS 5/205(1)(d), (“Level D”) of the statutory schedule of priorities, 215 ILCS 5/205(1), (the “Priority Schedule”) and in support thereof states as follows:

1. Pursuant to an Order entered on May 8, 2013, Lumbermens, American Motorists Insurance Company (“AMICO”), and American Manufacturers Mutual Insurance Company (“AMM”) were placed into liquidation on May 10, 2013 (the “Liquidation Order”) under Article XIII, 215 ILCS 5/187 *et seq.*, (“Article XIII”) of the Illinois Insurance Code, 215 ILCS 5/1 *et seq.*, (the “Code”). The Liquidation Order included a finding that each of Lumbermens, AMICO, and AMM were insolvent. The three companies were subsequently merged, effective December 31, 2014, with Lumbermens being the surviving entity.

2. The Court subsequently entered an order approving the Liquidator's petition to establish a claims procedure pursuant to Sections 208 and 209 of the Code, 215 ILCS 5/208 and

209. That order established May 10, 2014, as the claim filing deadline for claimants to present their claims against the Estate in order to share in any distributions of Estate assets made on timely filed claims, and November 10, 2017, as the deadline for an insured to submit evidence of the liquidation by payment of timely filed contingent claims.

3. Pursuant to the requirements set forth in Section 209, *id.*, (“Section 209”) the Liquidator has reviewed the 1,000 claims identified in Exhibit 1 to this Petition and now seeks this Court’s approval of her uncontested recommendations for the disallowance of each such claim for purposes of barring their participation in any distributions of Estate assets that may be made on claims allowed at Level D.

4. Section 209 provides, in part, as follows:

(12) The Director shall review all claims duly filed in the liquidation … proceeding, unless otherwise directed by the court, and shall make such further investigation as he considers necessary...

(11)(a) When the Director denies a claim or allows a claim for less than the amount requested by the claimant, written notice of the determination and of the right to object shall be given promptly to the claimant or the claimant’s representative by first class mail at the address shown on the proof of claim. Within 60 days from the mailing of the notice, the claimant may file his written objections with the Director. If no such filing is made on a timely basis, the claimant may not further object to the determination.

(b) Whenever objections are filed with the Director and he does not alter his determination as a result of the objection and the claimant continues to object, the Director shall petition the court for a hearing as soon as practicable and give notice of the hearing by first class mail to the claimant or his representative and to any other persons known by the Director to be directly affected, not less than 10 days before the date of the hearing.

(13)(a) The Director shall present to the court reports of claims reviewed under subsection (12) with his recommendations as to each claim.

(b) The court may approve or disapprove any recommendations contained in the reports of claims filed by the Director, except that the Director’s agreements with claimants shall be accepted as final by the court on claims settled for \$10,000 or less.

215 ILCS 5/209(11)-(13) (emphasis added).

5. The Priority Schedule controls the order in which claims allowed in these proceedings participate in any distributions of Estate assets that may be made, as follows:

Sec. 205. *Priority of distribution of general assets.*

(1) The priorities of distribution of general assets from the company's estate is to be as follows:

(a) The costs and expenses of administration, including, but not limited to, the following:

(i) The reasonable expenses of the Illinois Insurance Guaranty Fund, the Illinois Life and Health Insurance Guaranty Association, and the Illinois Health Maintenance Organization Guaranty Association and of any similar organization in any other state, including overhead, salaries, and other general administrative expenses allocable to the receivership (administrative and claims handling expenses and expenses in connection with arrangements for ongoing coverage), but excluding expenses incurred in the performance of duties under Section 547 or similar duties under the statute governing a similar organization in another state. For property and casualty insurance guaranty associations that guaranty certain obligations of any member company as defined by Section 534.5, expenses shall include, but not be limited to, loss adjustment expenses, which shall include adjusting and other expenses and defense and cost containment expenses. The expenses of such property and casualty guaranty associations, including the Illinois Insurance Guaranty Fund, shall be reimbursed as prescribed by Section 545, but shall be subordinate to all other costs and expenses of administration, including the expenses reimbursed pursuant to subparagraph (ii) of this paragraph (a).

(ii) The expenses expressly approved or ratified by the Director as liquidator or rehabilitator, including, but not limited to, the following:

(1) the actual and necessary costs of preserving or recovering the property of the insurer;

(2) reasonable compensation for all services rendered on behalf of the administrative supervisor or receiver;

(3) any necessary filing fees;

(4) the fees and mileage payable to witnesses;

(5) unsecured loans obtained by the receiver; and

(6) expenses approved by the conservator or rehabilitator of the insurer, if any, incurred in the course of the conservation or rehabilitation that are unpaid at the time of the entry of the order of liquidation.

Any unsecured loan falling under item (5) of subparagraph (ii) of this paragraph (a) shall have priority over all other costs and expenses of administration, unless the lender agrees otherwise. Absent agreement to the contrary, all other costs and expenses of administration shall be shared on a pro-rata basis, except for the expenses of property and casualty guaranty associations, which shall have a lower priority pursuant to subparagraph (i) of this paragraph (a).

- (b) Secured claims, including claims for taxes and debts due the federal or any state or local government, that are secured by liens perfected prior to the filing of the complaint.
- (c) Claims for wages actually owing to employees for services rendered within 3 months prior to the date of the filing of the complaint, not exceeding \$1,000 to each employee unless there are claims due the federal government under paragraph (f), then the claims for wages shall have a priority of distribution immediately following that of federal claims under paragraph (f) and immediately preceding claims of general creditors under paragraph (g).
- (d) Claims by policyholders, beneficiaries, and insureds, under insurance policies, annuity contracts, and funding agreements, liability claims against insureds covered under insurance policies and insurance contracts issued by the company, claims of obligees (and, subject to the discretion of the receiver, completion contractors) under surety bonds and surety undertakings (not to include bail bonds, mortgage or financial guaranty, or other forms of insurance offering protection against investment risk), claims by principals under surety bonds and surety undertakings for wrongful dissipation of collateral by the insurer or its agents, and claims incurred during any extension of coverage provided under subsection (5) of Section 193, and claims of the Illinois Insurance Guaranty Fund, the Illinois Life and Health Insurance Guaranty Association, the Illinois Health Maintenance Organization Guaranty Association, and any similar organization in another state as prescribed in Section 545. For purposes of this Section, “funding agreement” means an agreement whereby an insurer authorized to write business under Class 1 of Section 4 of this Code may accept and accumulate funds and make one or more payments at future dates in amounts that are not based upon mortality or morbidity contingencies.
- (e) Claims by policyholders, beneficiaries, and insureds, the allowed values of which were determined by estimation under paragraph (b) of subsection (4) of Section 209.
- (f) Any other claims due the federal government.

- (g) All other claims of general creditors not falling within any other priority under this Section including claims for taxes and debts due any state or local government which are not secured claims and claims for attorneys' fees incurred by the company in contesting its conservation, rehabilitation, or liquidation.
- (h) Claims of guaranty fund certificate holders, guaranty capital shareholders, capital note holders, and surplus note holders.
- (i) Proprietary claims of shareholders, members, or other owners.

215 ILCS 5/205 (emphasis added).

6. Each of claims identified in Exhibit 1 to this Petition is a worker's compensation claim as to which the applicable state guaranty fund or association has assumed responsibility for the payment of all future benefits. The Estate has no further liability to these claimants (although the Estate retains liability for the claims of the state guaranty funds and associations for reimbursement).

7. As required by the notice requirements set forth in Section 209(11), *supra*, each of the 1,000 claimants identified in Exhibit 1 to this Petition were mailed a notice of determination ("NOD") advising them of the Liquidator's recommendation that their claim be disallowed and barred from participating in any distributions of Estate assets that may be made on claims allowed at Level (D). In addition to notifying each claimant of the Liquidator's recommendation for the disallowance of their claim, the Liquidator's NOD also informed each claimant of their statutory right to object to the Liquidator's recommendation, and to a hearing if their objection could not be resolved.

8. There are no pending objections on any of the claim recommendations identified herein.<sup>1</sup> The 1,000 claim recommendations identified in Exhibit 1 to this Petition are accordingly uncontested.

1. With respect to the 1,000 claims identified in Exhibit 1, the Liquidator was unable to identify a current address for the 6 claimants listed in rows 1-6, the 110 claimants listed in rows 7-116 did not respond to the NOD within the statutorily required 60-day period, the 3 claimants listed

WHEREFORE, the Liquidator requests that this Court enter an order approving her recommendations for the disallowance of the 1,000 claims set forth in Exhibit 1 to this Petition and barring each such claim from participating in any distributions of Estate assets that may be made on claims allowed at Level D.
